Sadly, Alan passed away that same year after a long fight with cancer. I was one of the fortunate individuals to know and work with Alan. He was always giving his time to others, especially those starting out in our industry. Alan knew, as John F. Kennedy said, that "one person can make a difference, and everyone should try." year to the Alan Steiman Scholarship Fund and in the entrepreneurial success stories of its recipients.

Since the scholarship's inception, approximately 98% of recipients have become SIMA members after attending their first Symposium. They continue to participate and hone their business acumen and knowledge of snow and ice management while networking within the industry.

"The Symposium allowed me to realize I have a deep passion for the snow and ice industry — something I wasn't aware of," said 2019 recipient Kevin Shackleford of Shackleford Landscape Group. This is precisely the vision Alan and the SIMA board had in mind when they created this scholarship fund in 2010.

Expanding efforts

Fast forward 10 years, and today's SIMA

board has directed the creation of a new organization, the SIMA Foundation, a 501(c)3 non-profit whose mission is three-fold:

- (1) to provide scholarships and training for activities that attract, develop and retain professionals in the snow and ice management industry;
- (2) to conduct research and benchmarking studies on issues impacting industry stakeholders; and
- (3) to work on increasing public and stakeholder awareness and education on the value of snow and ice management services and its role in risk management and public safety.

The Foundation's first steps will focus on growing the Alan Steiman Scholarship Fund and creating new educational scholarships in remembrance of other industry heroes.

It will look for new ways to expand affordable educational offerings and to educate the public and the property management industry on the importance of hiring a well-trained and certified snow professional.
