

## SIMA Stakeholder Advisory Group

### SIMA 10-2020 Revision, Standard Practice for Procuring and Planning Snow and Ice Management Services

**Scope:** The individual stakeholder advisory groups of the SDC shall be responsible for the following: a) Developing and maintaining appropriate content for the proposed SIMA standard within its scope, as assigned by the SDC; b) Voting on approval of appropriate content for the proposed SIMA standard within its scope. Each stakeholder advisory group will have a consensus body vote, as defined in the ANSI Essential Requirements, for the proposed SIMA standard; c) Submitting its area of work to the SDC for final review and consideration; d) Responding to requests for interpretations of the standard subject content developed by the stakeholder advisory group; e) Acting on other matters requiring stakeholder advisory group effort as provided in these procedures or assigned by the SDC; f) Cooperating with other standards development organizations. This includes resolving potential conflicts with existing American National Standards and candidate American National Standards, as described by ANSI; and g) Reporting to the SDC as requested for the purposes of general information.
